Furthermore, the JC Human Resources Consulting PersonalberatungsGmbH has the right to select a part of each piece of music of up to 60 seconds according to its choice and upload it - as well as listening-samples provided along with the pieces of music - onto the above mentioned website

as a listening-sample for free download. These rights are granted for free and I cover any expenses related to this agreement myself.

The sales price of each title is € _____ (the minimum price to be set is € 0.50) before taxes. The JC Human Resources PersonalberatungsGmbH has the right to keep 40% of this amount (before taxes), however a minimum amount of € 0.50, as remuneration for the sales service. Moreover, it has the right to offer and sell jointly (package) two or more pieces of music selected among those included in the site. In this case I will receive not less than the respective amount due to single item sales. Payments will exclusively be made to GEMA (www.gema.de), Germany, which distributes the amount received according to its ruling terms and conditions.

I accept that the JC Human Resources Consulting PersonalberatungsGmbH is not obliged to include in any way a piece of music in the website „www.musicxsound.com“ and has the right to remove any piece of music at any time for what reason ever without giving notice. Any liability for damage or losses due to the removal is excluded.

A piece of music included in the website will be removed from it within four weeks after receiving written notice by the owner of the intellectual property right to do so.

I explicitly state to agree that JC Human Resources Consulting PersonalberatungsGmbH excludes any liability for damage or losses due to the illegal use of a piece of music by a third party, including illegal download. Moreover, any liability for problems, damage and losses related to the technical functionality of the website (especially access and download) is excluded.

I am obliged to update all relevant data immediately in written form in case of changes and I accept full liability for damage and losses incurred by the JC Human Resources Consulting PersonalberatungsGmbH due to wrong or incomplete data and/or information given in this agreement, especially related to intellectual property rights as well as to claims due to the contents of lyrics.
